TIMEZONE SUMMER SCHOOL HOLIDAYS GIVEAWAY

TERMS AND CONDITIONS

Definitions:

Immediate Family: means spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

Promoter: means TEEG Australia Pty Ltd (ABN 61 003 710 110) of Level 8, 60 Miller Street, North Sydney, 2060 NSW, trading as Timezone.

Promotion: means the "Timezone Summer School Holidays Giveaway" governed by these terms and conditions.

Promotional Period: means the period commencing on 07/12/2022 at 09:00 AEDT and ending on 07/02/2023 at 23:59 AEDT

Qualifying Transaction: means the purchase of one (1) of the Summer School Holiday Timezone deals "Powerticket Millionaire \$60, Powerticket Millionaire \$70, Powerticket Millionaire \$100, Powerticket Millionaire \$120, Powerticket Millionaire \$250" in one transaction via the Timezone Fun App (available for download via the App Store or Google Play) during the Promotional Period.

Terms and Conditions:

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry into this Promotion is only open to Australian residents.
- 3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.

 Adding the Powercard in respect of which the Qualifying Transaction was processed to their account.

For clarity, individuals that make a Qualifying Transaction via the Timezone Fun App during the Promotional Period will receive an automatic entry into the Promotion.

- 7. Individuals who are entered into the Promotion and have opted in to receive marketing communications will receive an email and/or SMS confirming their entry. For clarity, those who do not opt in to receive marketing communications will still be a valid entrant, they will however not receive an email and/or SMS confirming entry into the Promotion.
- 8. Multiple Qualifying Transactions are permitted and, subject to the registration requirements, will result in multiple entries into this Promotion.
- 9. Where an entrant makes a Qualifying Transaction, the entrant must retain the Timezone Powercard which was used to make the Qualifying Transaction, clearly showing the card number for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of all of an entrant's entries and forfeiture of any right to a prize.
